Floyd John Psencik, 92, of Rosenberg, Texas passed away on June 6, 2024 at his home surrounded by family. He was born on February 24, 1932 in Richmond, Texas to Will Joseph Psencik and Lydia Shefcik Psencik.

In early years, Floyd was a farmer and then worked for Borden's Company delivering milk. Later on, he went to work for Houston Lighting and Power Co. where he worked for 32 years before retiring in 1987. He painted paintings, did wood working, built custom cabinets, enjoyed remodeling their home with his wife, Jeanette, repaired machinery, cars, electronics and anything that needed fixing. He could repair anything and everything and loved doing it because he had a great joy of satisfaction in making things look and perform better.

He loved his family and enjoyed getting together with them. Whether it was for a back yard BBQ for family, fishing trip, vacation, or an evening visit. He and his wife enjoyed many fishing trips at their little cabin with family and friends. Floyd was always ready to help someone out when they needed help. He never hesitate to go when they called.

Floyd was a member of St. Paul's Presbyterian Church in Needville, Texas

and an Ordained Elder. Later after transferring his membership to First Presbyterian Church in Rosenberg, he was elected to serve as an Ordained Deacon and served on the Board of Deacons. He also served on the Fellowship and Personnel committee.

In addition to his parents, Floyd is preceded in death by his brothers, Daniel Psencik, and Clinton Psencik (Infant); and his in-laws, William and Marcella Schwettmann.

Survivors include his wife of 69 years, Jeanette Schwettmann Psencik; children, Lenore Ann Psencik and Don Allen Psencik and wife, Dalia; sister, Alice Gregory and her husband, M.C. and their children; brother-in-law and sister-in-law, Richard and Geraldine Schwettmann and their children; along with extended family and a host of friends.
