



## Logene Leslie Foster

Logene Leslie Foster (89) of Fulshear, Texas, passed away on February 17, 2024 at his home. He was born on July 20, 1934 in Goforth, Hays County, Texas to Leslie and Madeline Foster. He lived and grew up in Buda, Texas and later graduated from Buda High School. Logene was married to the love of his life, Agnes Marie Polasek Foster for 65 years,

Logene was a member of the National Guard Reserves and was a Texas State Trooper with the Department of Public Safety. Logene later attended South Texas College of Law where he received his law degree. Logene was the first attorney in Sugar Land, Texas and practiced law for over 50 years. He was board certified in family and criminal law. Logene started his law firm in Sugar Land TX in 1966 in a one room building behind the Imperial Sugar Company. He later moved his practice across the street and years later was joined by two sons Lynn and Lonnie Foster. Logene was also a member of the Jaycees and Lions Club of Sugar Land. Logene could be found at the Sugar Land Little League Fields where he coached all his son's baseball teams.

Logene is survived by his wife, Agnes; sons, Larry (Jamie Peay), Lonnie (Kim) and Lynn (Tracy); sister, Sybil Ray Ellison; grandchildren, Cole (Jess), Chandler, Kyler, Koby, Georgia Arrick (Zach), Alex Sweet (Andrew), Jessica and Heather; great grandchildren, Hannah & Elliot Arrick and Asher Sweet; along with extended family, friends, and colleagues.

In addition to his parents, Logene is preceded in death by his infant son, Logene Leslie Foster, Father and Mother-in-law Theo and Agnes Polasek, his brother-in-Laws Eddie Ellison, John Polasek and Joe Polasek.

Beyond his professional achievements, Logene cherished spending time with his family and friends on annual trips camping at Lake Sommerville, Fishing trips in Matagorda and Port O'Connor, where they would spend several extended weeks bonding and creating lasting memories. Other outdoor activities he enjoyed were snow skiing in Breckenridge, Colorado. Water skiing on the San Bernard River. Back in the day Logene would host ski parties on the river and invited prosecutors, defense attorneys, judges, and court staff where they would all enjoy a weekend of fun. Another passion shared by Logene and Agnes was the start of L&A Stables and their horse racing adventure. Larry was their devoted trainer, and they spent many years in Bandera and other racetracks. They not only ran horses, they also bred and raised thoroughbred and quarter horse racehorses on their ranch in Fulshear, Texas.

Logene cherished his time with family and friends. He was a loving husband, father and grandfather and would do anything for his family or friends. He was known for his sharp wit, dedication, and committed to not only his work but to life. He will be deeply missed by all who had the privilege of knowing him.
