August 13, 1941 - January 20, 2011

Woodrow Woodie Coppedge passed away on Thursday, January 20, 2011 at the age of 69. He was born in Yoakum, Texas on August 13, 1941.

Woodrow, "Woodie", as most knew him, was in the USAF and was retired from Santa Fe, Katy and Union Pacific Railroads. He worked as an Insurance Agent for the Knights of Columbus and was retired from the Xerox Corporation where he worked in San Antonio and Houston. Woodie loved golfing, traveling with his son and family to the Caribbean and visiting his daughter and son-in-law and their family in Florida. He was a Master Gardner.

He grew up in Hochheim and went to school in Sweethome where his mother taught school. He was a graduate of Kirwin High School in Galveston and had a degree from Galveston College.
